ADDITIONAL AERODROME INFORMATION**SOCIAL DISTANCE BOARDING PROCEDURES**

Social Distancing Boarding Procedure.

Due to social distancing, all departures will from now be boarded starting from aft sections and moving to forward sections progressively. To avoid ground stability challenges the following two rules must be followed:

1. Loading of bags/cargo must start with forward cargo compartments.
2. To assure an even distribution of passengers in the aisle, boarding must not be stopped once started.

Ground staff have received instructions of point 1 and 2 and no specific actions are normally required from flight or cabin crew.

Extract from Cessna 172 manual:**WINDSHIELD DAMAGE**

If a bird strike or other incident should damage the windshield in flight to the point of creating an opening, a significant loss in performance may be expected. This loss may be minimized in some cases (depending on amount of damage, altitude, etc.) by opening the side windows while the airplane is maneuvered for a landing at the nearest airport. If airplane performance or other adverse conditions preclude landing at an airport, prepare for an "off airport" landing in accordance with the Precautionary Landing With Engine Power or Ditching checklists.
